<u>Department of Natural Resources and Environmental Control (DNREC)</u> <u>EPCRA Reporting Program LEPC Report – July 2024</u>

1. RY 2023 Reporting Summary

Delaware facilities submit their EPCRA Section 312 reports (often referred to as annual Tier II reports) online using the Tier II Manager[™] (T2M) database. As of July 1st, the annual Tier II reports grew to 2714 for RY 2023, an increase of ~2% compared to RY 2022 at this time last year.

Tables 1-3 summarize key points of reporting such as total number of annual Tier II reports, active facilities, fee paying & fee exempt facilities with the total fee collection in 2024. Table 4 shows changes in EPCRA reporting in the last 2 months between previous & current LEPC meetings. A list of facilities missing their annual report have also been summarized in Table 5.

The tables below contain Tier II reporting data according to a facility's LEPC designation. Facilities usually determine their own LEPC, but these determinations should be verified by each LEPC. LEPC's can access and view the reports through the T2M system.

2. Status of Missing Facility Reports
